Physician Quality Reporting Initiative (PQRI) Quick Reference Card

In 2006, CMS created the Physician Quality Reporting Initiative (PQRI) which allows eligible professionals to participate in a voluntary quality reporting program. Those who successfully report a designated set of quality measures, using the quality-data codes on claims, will be eligible to earn a bonus payment (subject to a cap) of 1.5% of total allowed charges for covered Medicare physician fee schedule services.
